Recovery of Licence Fee and Water Charges amounting to Rs. 9956/-

(A) Short recovery of Licence fees amounting to Rs.7272/- pointed out in the old report 2006-07)

During the test-check of PBR for the audit period of 2006-07, it has been observed that Sh.Ramesh Kumar, Peon has been allotted Government accommodation at C-6, Nirmal Chayya Complex, Hari Nagar, ND. Deduction of Licence Fees is being @ Rs.45/- p.m. and no deduction on account of Watercharges is being made from the official. The rate of Rs.45/- p.m. in respect of Type-A quarter was applicable, since July 1990. Subsequently, Licence fees rate have been changed in July'93, July'96, July'99, April'01 and July'04. Also, the official was allowed to change to Type-II quarter, w.e.f. 15.03.04.

Accordingly, recovery of short payment of Licence Fees has been worked out as under :-

# (B) Recovery of Licence Fee and Water Charges amounting to Rs. 2684/- pointed out in fixe current Audit

While test audit of Work centre for women for the audit period 2007-08 to 2013-14 it has been found that Sh. Ramesh Kumar, Peon was allotted Government accommodation, Type – II quarter, at Nirmal Chayya complex, Hari Nagar w.e.f. March 2004, but it has been observed that licence fee and water charges have not been recovered as per revised rates for the following months

Sh. Ramesh Kumar was shifted to 625, Type-I, Gulabi Bagh, w.e.f. January 2010 but the recovery of licence fee and water charges have been w.e.f. March 2010, the licence fee and water charges have not been recovered for two months.

Further, w.e.f. July 2012 the rates of L/fee were again revised from Rs. 80 to Rs. 115 and water charges were revised from Rs. 09 to Rs.157 pm. Sh. Ramesh Kumar was transferred from Sept. 2012 but as per PBR the deductions of L/Fee and Water Charges as per revised rates have not been made,

#### TEST AUDIT NOTES

#### Sub. Non-Implementation of the Scheme

Work centre for women, Department of Social Welfare, was started in 1982 with the objective to provide training of cutting and tailoring to the female inmates lodged in the Tihar Jail, so that after their release from jail the inmates could earn their livelihood by self employment.

As per record only two posts i.e. one junior craft instructor and one peon was the sanctioned strength of the unit. Out of which junior craft instructor was retired on superannuation in the month of March 2005 since then no instructor has been appointed/deputed in the unit, and one post of the peon was filled up to August 2012 and after that he has been transferred to other unit.

As since April 2005 the unit was non-functional, on 13.01.09 the jail authorities requested that either a craft instructor may be appointed/posted or vacate the training room, so that the training centre can be used for other activities. The room was vacated by the department and on 18.09.12 all the 14 equipments/training items were auctioned by the department for Rs. 4000/-.

Currently all the sanctioned post of the department are lying vacant since long, and even the department does not have the training material/machinery, but one superintendent and one ministerial staff are working in this unit on additional charge/diverted capacity.

As the unit is non-functional from last more than nine years and since then no craft instructor has been appointed and no training has been given to the women/inmates of the jail, and the purpose of the unit is defeated.

Efforts may be made to implement the scheme.

#### Sub. Discrepancies found in cash book

While scrutiny of the cash book following discrepancies have been noticed

- 1. The cash book has not been written/closed after Feb.2013
- 2. As per TR-5 an amount of Rs. 4000/- was received from Sh. Mannu on 18.09.12, as auction money whereas the same has been entered in the cash book on 24.09.13 i.e. after 06 days
- 3. An amount of Rs. 3000/- was sanctioned as imprest money, as per cash book after Aug. 2012 the imprest money has not been used, and the unutilized imprest amount is lying in the office since August 2012, the unutilized Govt. money has not been deposited in Govt. account till date.
- 4. Cuttings in cash book have not been attested by the DDO
