INTRODUCTION

Test Audit on account of Inclusive Education Branch (IEB), Lajpat Nagar-IV for the period 2018-19 to 2022-23 has been conducted by the Audit Party No.VII comprising of Sh. Dinesh Kumar Dhawan, Sr. AO/IAO, during the period from 09.10.2023 to 18.10.2023.

AIMS & OBJECTIVES

Admission of children with disabilities, Implementation of various interventions under inclusive education, redressal of grievances in respect of inclusive education of children with disabilities, recruitment of special education teachers (SETs), transfer/posting of SETs etc. Now, the IEDSS-CSS scheme under integrated RMSA is replaced by Govt. of India with new Samagra Shiksha Abhiyan (integrated scheme for school education), from the year 2018-19, which has the provision for inclusive education of children with disabilities from pre-primary to higher secondary level.



Performance of IEDC(Integrated Education for Disabled Children), Begumpur

AIMS & OBJECTIVES

The IEDC is an administration cell headed by Dy Director of Education started in 2006-07 in Begumpur under Directorate of Education which is implementing agency for Centrally Sponsored Scheme Integrated Education for Disabled Children. This is a centrally sponsored scheme under which the Ministry of HRD, Central Govt. will assist the state government/UT in its implementation and assistance for all the items covered in the scheme will be on 100 percent basis but assistance for the program would be conditional on provision of professionally qualified staff.

The scope of the scheme includes pre school training for the disabled children and counseling for the parents. The education of the disabled children will continue upto the senior secondary school level and includes vocational courses equivalent to the senior secondary stage. The disabled children who are placed in special schools should also be integrated in common schools once they acquire the communication and daily living skills at the functional level.


MANPOWER ENGAGED

Progress of IEDC scheme in Schools under Dte. of Education

Non receipt of Grant-in-aid (A)

No Grant-in-aid has been receiving by the Delhi Govt during the period 2006-07 to 2008-09 for implementation of the IEDC scheme in schools under the control of Dte. of Education, Delhi. Due to non receipt of the grant, disabled children in the government school deprived of the benefits i.e. books & stationery, uniforms, equipment allowance etc. as admissible under the scheme during this audit period. Department has submitted consolidated proposal amounting to Rs. 67,42,799/- M/o HRD for release of grant to reimburse the amount to eligible students during the school period. Still the proposal is lying with the M/o HRD for release of grant.

Directorate of Education, Govt of NCT of Delhi may take up the matter to the higher sauthorities of M/o HRD to release the grant-in-aid immediately to the Delhi govt. for implementation of the scheme in Delhi govt schools so that no disabled children studying in govt school should be deprived of his/her right under the IEDC scheme The details of disabled students in DOE schools identified for getting benefit during 2006-09 is given below:-

SPECIAL TEACHERS (B)

As per guidelines "Except for children with loco motor disabilities, special education teachers may be appointed in schools where the scheme is in operation to provide specific attention to the disabled children. The teacher pupil ratio for special education teachers envisages under the scheme is 1:8. this ratio will be same for normal classes as well as for preparatory pre school classes. The same teachers will provide counseling to the parents. In accordance with this ratio the requisite number of special teachers may be appointed in schools(or for a cluster of schools) for children requiring special teacher support." As per

information provided by the IEDC, Begumpur number of disabled children in govt. schools are 10065 and 8988 during the year 2007-08 and 2008-09 respectively. But till date only 6 special teachers have been appointed by the department who are working at present. Now the department has mooted a proposal for the creation of one posts in every school of DoE i.e. 926 posts of special education teachers in the scale of PGT. The proposal is awaiting final approval of the competent authority.

Before creation and appointment of these posts Die Of Education/IEDC may ensure whether M/o HRD, GOI will extend the grant in for these posts. If not, who will bear the expenditure involved on this account. Prior approval of competent authority i.e. M/o HRD, GOI & Delhi Govt may be obtained in the matter to avoid any complication in incurring

A resource room having all the essential equipment learning aids and materials to be provided for a cluster of schools implementing the scheme of integrated education but resource room has been set up by the Department for government.

(D) TRAININGS

(D)

All the training responsibilities pertaining to the Heads of Schools, EVG Counselors, District Co-ordinators and teachers for their sensitization towards schemes and Persons with Disability Act have been entrusted to the SCERT by the Department. As per guidelines "The State Government/UT Administations may organize orientation programmes of three days duration for heads of the institution and of five days duration for general teachers of the institutions implementing the IED scheme with the help of RCDs, Regional Training Centres and DIETs for the handicapped." But the Department has not organized orientation programmes for heads of the institutions and provided three days training to trained graduate teachers and assistant teachers from 27th January to 02 Febrauary,09. Department may conduct training programmes to Head of Schools and other staff also as required under IEDC scheme.

EXHIBITIONS (E)

IEDC has informed that exhibitions are conducted/ arranged for creating awareness in the community by the District Coordinators in their respective 09 districts. But no details of exhibitions conducted during audit period not provided.

(F) As per information provided by IEDC cell the state has identified only 0.28/of children with special needs(CWSN) as compared to the accepted norms of 3% CWSN. This is a very serious issue and need serious efforts to identify the remaining CWSN

According to Inspection report, it was observed that only after November,08 teachers are meeting regularly the Head of School/Teachers in government schools were visually impaired/blind students from NAB are studying. For more than 25 visually impaired students in G.Coed.SSS Sector-V R.K.Puram, only two teachers are assigned. Further no orientation programme for the staff of the schools has even been undertaken by these teachers which are mentioned as one of their duties. Aslo no special workshops have been organized(to create awareness and sensitization about various issues regarding integrated education) for the nearly government schools where students from NAB are studying. No specific adapoted instructional material i.e. embossed maps, tactile diagram etc. has been sent to any of the government schools. For mathematics and Science where students need maximum help in the classroom studies, no resource teacher has been deputed for this.

Further, no service book has been maintained for teachers and other staff.

Department has not initiated any action in this matter.

As per the Notification No. 50/2018-Central Tax dated 13.09.2018 by CBIC it was decided that the TDS would be made operational w.e.f 01.10.2018 @ 2% is to be deducted from the payments made to the firms if the gross amount to be paid to the vendors is equal to or more than 2,50,000/- Similar notifications have been issued by respective State Government.

During the scrutiny of bills for the audit period 2018-19 to 2022-23 the following discrepancies have been found. The items mentioned in the given below bills comes under GST act, the contractors were registered for GST and have got registration number also as mentioned in their bills & contractors also charged GST on the below mentioned bills. The amount paid to the vendors during a financial year is more than Rs.250000/- but Inclusive Education Branch has not deducted @2% GST from the bills.
